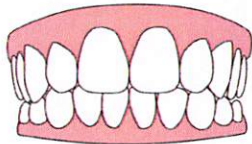
### We Care About You

### Adult Plan

- Professional Cleanings: 2 visits / year (every 6 months)
- Periodic Exams: 1-2 / year
- Needed X-Rays: 1 set of bitewings/ year and full mouth series or panoramic every 5 years.
- Fluoride treatment as necessary
- If needed, one emergency exam per year, including 1 x-ray (if necessary)
- 15% off other treatment-excluding over the counter products. 10% if using 3<sup>rd</sup> party financing. (Ex. Care Credit)
- Annual periodontal evaluation
- Annual oral cancer screening
- Denture / Partial cleaning, if applicable

### Child Plan

- Professional Cleanings: 2 visits / year (every 6 months)
- Periodic Exams: 1-2 / year
- Needed X-Rays: 1 set of bitewings/ year and full mouth series or panoramic every 3 years.
- Fluoride treatment
- If needed, one emergency exam per year, including 1 x-ray (if necessary)
- 15% off other treatment - excluding over-the-counter products. 10% if using 3<sup>rd</sup> party financing.



### Periodontal Plan

- Periodontal Maintenance: 3 visits / year (every 4 months)
- Periodic Exams: 1-2 / year
- Needed X-Rays: 1 set of bitewings / year and full mouth series or panoramic every 4 years.
- Fluoride treatment as necessary
- If needed, one emergency exam per year, including 1 x-ray (if necessary)
- 15% off other treatment-excluding over-the-counter products. 10% if using 3<sup>rd</sup> party financing.
- Annual periodontal evaluation
- Annual oral cancer screening

All treatment must be **paid in full at each visit** to keep the plan in effect.
